Power Based Violence (PBV)

The Fletcher Technical Community College faculty/staff designated as Responsible Employees (RE) required training for 2024 is underway. Fletcher Technical Community College has a total of 298 Responsible Employees and 6 Confidential Advisors. RE training rolled out in March 2024 with 227 (76%) RE and 6 (100%) of the Confidential Advisors have completed training. The low completion rate currently is attributed to the timing of the annual training rollout with a completion deadline set for December 31, 2024. In 2023, we had 259 (100%) Responsible Employees who completed training. The participation numbers and rate fluctuate from month to month due to changes in personnel. Additionally, 100% of the full-time employees at Fletcher Technical Community College have completed the required annual sexual harassment training for 2023 with 100% of supervisors completing annual sexual harassment for supervisors training.
