## Power Based Violence (PBV)

The Fletcher Technical Community College faculty/staff designated as Responsible Employees have not all completed the required training. Currently, we have 248 of Responsible Employees completing training. Fletcher Technical Community College has a total of 258 Responsible Employees and 6 Confidential Advisors. So far, 96% of Responsible Employees and 100% of the Confidential Advisors have completed their annual training. This number changes due to new hires who have 90-days to complete required training. Additionally, 100% of the full-time employees at Fletcher Technical Community College have completed the required annual sexual harassment training for 2023 with 100% of supervisors completing annual sexual harassment for supervisors training.
